





New Subject: Moral and Sustainability

contractworld 2011 will take place under a motto, which addresses a topical subject: The central theme "Moral" is the principal motto of the entire event, and in various forms it is made a subject of discussion in the lectures.

In view of current events such as the Cologne underground scandal, the banking and economic crisis as well as the abuse scandal, the desire for sincerity, honesty and moral is growing. This is reason enough, to give the contractworld in January 2011 exactly this theme: In all four subject blocks (Office, Hotel, Shop, and Conversion), architecture-related ethic lectures will be given, which deal with the subject of moral in various degrees. J. Mayer H. commences the Office category with his lecture "activators", and in the first round of Architecture + Dialogue, Peter Camenzind converses with a personality from the world of literature. In the Hotel block, the topic is the trend towards more and more manifold and specialised concepts (eco, single, cloister hotel). The architects dealing with shop designs must deal with the subject of moral in view of increasingly better educated and more interested customers. In the Conversion category, the discussion focuses on protestant churches, which were converted into secular buildings.



Another important subject of contractworld 2011 is sustainability. Not just the congress offers lectures on resource conservation and efficiency, for the award and the exhibition this special subjects plays an important role, too.

Any form of sustainable thinking has its origins in ethical aspirations, in a moral attitude. Therefore, the sustainability debate cannot be answered with philosophical considerations alone. Quite the contrary: Planners must make decisions and manufacturers must know on what premises these decisions are based, so that they are able to develop and provide the corresponding products. For that reason, contractworld 2011 dedicates a separate plaza to the **sustainability** topic: Here, the visitors can attend various seminars as well as a special Sustainability Symposium on Monday January 17. Furthermore, several speakers take on the subject in the Forum. The lecturers on the Sustainability Plaza consider the material aspect as well as subjects such as architecture export, energy-efficient building and the training to become a planner of passive houses. This year, sustainability has also been an important criterion for the assessment of projects submitted to the contractworld.award.

Topical: Conversion as fourth category

Apart from the regular classic subjects Office, Hotel and Shop, there is an additional annually changing category dedicated to a current topic. For contractworld 2011, the organisers selected the field of conversion of existing buildings.

Not just renovating or refurbishing an existing building, but giving it a new use presents architects and interior designers with a significant challenge. In particular in densely developed inner cities, vacant or dilapidated buildings offer the possibility to sustainably use existing resources. In January 2011, as before in 2009, such conversion projects will be presented. The category comprises conceptually outstanding changes of use and appealing interior design solutions for existing buildings from the sacral, cultural and public sphere. These include churches, cloisters and hospitals as well as prisons, railway stations or disused industrial buildings. Particular emphasis is

placed on the ethically respectful treatment of urban, social and cultural buildings - truly in line with the current contractworld themes of "Moral and Sustainability". 79 projects from Germany and abroad were submitted in this exciting category. The variety of projects illustrates the great potential of conversions: Nuclear bunkers were converted into offices, courtyards into reference rooms and military buildings into hotels. In addition to the three winners from Sweden, China and the Czech Republic, five additional projects were shortlisted due to the high quality of submitted works. The award-winner of the New Generation, that is the group of those under the age of 40, will be determined in a live jury session on the respective theme

Award: Ten jury members assess the projects



Divided into two groups, the ten-member jury assessed the submitted works in several phases.

The jury has made a decision: The ten-member jury comprising architects, interior designer and architecture theoreticians assessed the 525 project submitted for the contractworld.award during a two-day jury session. The comprehensive list of applicants illustrates that this competition for innovative interior concepts is internationally recognised - projects from 34 countries were submitted.

For the eleventh time, the contractworld.award **Störme**r (Störmer Murphy and Partners, DE-Hamburg), Much Untertrifaller (Dietrich | Untertrifaller Architekten, AT-Bregenz), and Bostjan Vuga (Sadar + Vuga, SL-Ljubljana). On August 19 and 20, 2010, the jury members already agreed on the winners in the four categories. However, the public will only be informed about the ranking on January 15, 2011 in the context of the festive award ceremony during the contractworld. This year, sustainability was a new criterion for the assessment of projects. In view of the high quality of submitted works, the jury, which was chaired by Jan Störmer and Kim Herforth Nielsen, drew up an additional shortlist. In the New Generation group, the jury opted for a shortlist one can be proud of. The award ceremony of the New Generation will take place on the theme day of the respective category.
